

### **Success Story Example: Mandalay Resources**

Mandalay Resources is a Canadian-based natural resource company that focuses on growing its production and reducing costs to generate significant cash flow. As of 2019, they have begun operations in Sweden in the Björkdal gold mine in Northern Sweden. During this acquisition, they eliminated the costs associated with open-pit mining operations and increased the underground production capacity.

#### The National Research Council of Canada Industrial Research Assistance Program (NRC IRAP)

NRC IRAP is Canada's leading innovation assistance program for small and medium-sized businesses. IRAP is a funding program designed by the Canadian government to increase innovation and speed of research and development projects. NRC IRAP helps innovative small or medium-sized businesses in Canada to build innovation capacity and take ideas to market through financial assistance, advisory services, and connections to the best business and R&D expertise in Canada.

# Joint NRC IRAP Funding Programs for R&D Co-Development Projects between Canada and Sweden

Eurostars Eureka | Eurostars (eurekanetwork.org).

Eurostars is the largest international funding programme for SMEs wishing to collaborate on R&D projects that create innovative products, processes, or services for commercialization. Generally, Canada and Sweden have funding for each semi-annual Call. Project selection is made centrally, and funding criteria are national. The registration deadline for Canadian SMEs is 16 March 2023, and the application deadline is 25 April 2023.

#### Eureka Clusters, Eureka | Clusters (eurekanetwork.org).

Eureka Clusters are industry-led international communities focused on strategic technology areas that aim to meet market needs and solve economic, technological, and societal challenges. Canada currently funds all five Clusters (including EUROGIA2030 (sustainable energy), whereas Sweden has funding for have funding for the following: **CELTIC-Next** (information and



communications technology), **ITEA 4** (software), **Xecs** (electronics), and **SMART** (manufacturing). Each Cluster typically launches an annual Call for proposals in the Fall (except CELTIC-NEXT, which has two calls annually).

#### **Eureka Network <u>Eureka Network | (eurekanetwork.org).</u>**

The Eureka Network is mostly used to set up calls for proposals whether bilateral, multilateral, or national. Sweden has funding and accepts Eureka Network proposals year-round from SMEs, large firms, universities, and research centres. Canada has participated in many bilateral and multilateral Calls where NRC IRAP reserves funding for Canadian SMEs.

- National funding bodies from Sweden and Canada are funding research and development projects in lightweight technologies in areas of Energy and resource efficiency, Creation of sustainable value circles, and bolstering lightweight integration in more areas.

#### Alberta Innovates' International Technology Partnership (ITP) Program

The ITP Program supports Alberta-based SMEs to commercialize their products, achieve an optimal market position, increase revenue, and potentially expand into global markets. SMEs in the Program receive funding to find and enter into a partnership with an "International Project Partner." Within these partnerships, SMEs have the opportunity to pilot their product's technical and business merits, further product development, and advance commercialization. The Program is designed to de-risk the commercialization process by offering funding and coaching to eligible companies.

An estimated budget of €26.2 billion for 2021 provides opportunities for over 4 million participants to study, train, gain experience, and volunteer abroad. Canada is eligible for certain actions, as well as Erasmus Mundus scholarships.
